COMMUNITY COMMENTS

DISCUSSION	
•	Paul Shulman: Compliments to EAS for an excellent job – made sure all tested heat detectors were actually working
•	Rich Franco: Complement to EAS for an excellent job. They recorded his heat detectors working. He doesn't believe that previous companies have made this info available to residents.
•	Residents were advised that the Fence survey will have to be different than the one that we did for the plantings. Our recent survey cost \$4,000 which included trees, plants, etc.
•	Joe C: With regard to personal planting in the common areas, we have had continual complaints that 4D pricing is unreasonable. We have discussed it as a board and with 4 D and if they don't adjust their pricing we are looking to include other vendors for competitive prices. To be continued.
•	Jon Weber made a complaint about tree on his common area, which fell down and 4 D replaced it with 3 huge trees. He felt this was not cost efficient. He believes that 4 D needs to be re-evaluated.
•	Residents expressed concern over the tree hanging over Hulse as a serious concern. We all need to call and complain to the highway department or to the town councilman, as this is the only way we are going to be heard.
•	There is a large tree hanging over Hulse, since it doesn't interfere with PSEG line we have to look to the Highway department to trim it and not to PSEG.
•	Diane Ward: Suggests that the trees need regular maintenance; currently she believes they need to be sprayed
•	Dorane: Suggests that trees with roots pushing up under cement and ruining the payment, should be replaced, a little at a time, with trees that have a smaller root base.
•	Joe C: It would be too huge to do this (over \$100,000); but we are looking at this and how to resolve this.
•	Linda Hassenmeyer: With regard to the tree roots that are pushing up the driveways and pavements, she suggests that we remove the trees and not replace them.
